The following day, the capital region-based local news at Channel 10 did this news story: Governor Hochul to Make a Decision on Medical Aid in Dying Before End of Year.

I've spent a lot of time reading tea leaves and making sense of rumors and chatter around this for the past several months, and Governor Hochul's comment signals to me that we may be waiting until the end of the year for a decision from her. That means we have to keep the pressure on.

PS: Yesterday, September 30, I traveled to New York City to attend a hearing held by the New York State Assembly on creating legal pathways to access psilocybin. You can read a story about the hearing in Gothamist: <a href="New York state already legalized marijuana">New York state already legalized marijuana</a>. Could magic mushrooms be next? .... Why is this relevant in this email? Psilocybin has been shown in a variety of studies to help ease end-of-life anxiety (see,

e.g., <a href="https://www.nytimes.com/2024/12/17/health/psychedelic-medicine-palliative-care-end-of-life.html">https://www.nytimes.com/2024/12/17/health/psychedelic-medicine-palliative-care-end-of-life.html</a>), and I was monitoring the hearing carefully to hear what the experts had to say about this. There's a tremendous amount of interest among lawmakers for doing something on this front in the coming years, so stay tuned!

Relevant excerpt from <u>Spectrum Local News story</u> re: the Governor's comments on the Medical Aid in Dying Act:

At the event, Hochul also addressed multiple hot button issues in a briefing with reporters. While Hochul rarely if ever indicates to members of the press how she will act on a pending bill, she was asked for insight into how she planned to make her decision on the highly controversial Medical Aid in Dying Act, which would legalize assisted suicide in terminally ill individuals with guard rails in place.

Many have suggested that Hochul, a Catholic, could ultimately be swayed by her own faith to veto the bill. Hochul made an effort to put that speculation to rest Friday in some of her most extensive comments yet on the bill since it passed both houses of the state legislature this spring:

"As governor we're all products of our own circumstances and life influences, but I have to be very careful not to allow that to color my decision making when I'm making a decision not for myself but for 20 million New Yorkers," she said. "I do have the ability and have many times embarked on this to separate my personal beliefs, my religious beliefs, but I always have a very solid moral code that never leaves me when I make decisions for New Yorkers."

Advocacy groups on both sides of the issue responded to Hochul's comments Friday.

Corinne Carey, campaign director for Compassion & Choices in New York and New Jersey urged Hochul to pay attention to recent surveys on the issue:

"We are confident that Governor Hochul will do the right thing and act in the best interest of New Yorkers. In poll after poll, voters have said – by better than two-to-one margins – they support New York authorizing medical aid in dying and providing terminally ill patients with bodily autonomy at the end of their lives."

Multiple individuals experiencing terminal illnesses spoke with Spectrum News 1 last week pleading with Hochul to approve the legislation sooner rather than later given the medical implications.

While Dennis Poust, executive director of the NYS Catholic Conference, reiterated the organization's recent statements encouraging Hochul to take her time in deciding whether to sign the bill which they strongly oppose.

"We deeply appreciate Governor Hochul giving this decision the weight it deserves. It is a matter of life and death, after all. We are confident that, ultimately, she will come to the same conclusion as the American Medical Association which called assisted suicide 'incompatible with the physician's role as healer' and said it 'would be difficult or impossible to control,' and would pose serious societal risks."

The Center for Disability Rights likewise expressed appreciation that Hochul is "thoroughly examining the issue" and urged her to veto the legislation given what

they described as an increased risk of abuse faced by disabled and aging New Yorkers.
